Each tract is offered and the Lease for each tract will be issued for the acreage indicated, which may be more or less than the actual acreage. With respect to this tract 1, (Banner County 16-17-56) there is one shut-in but unplugged well: State (#1 State Brinkerhoff) located on this tract of land in the NW4SE4. The previous Lessee (RTA Petroleum, LLC) has a continuing legal obligation to plug this well. The successful bidder of this tract will have two (2) options pertaining to this well. 1) If the successful bidder does not want this well, then the previous Lessee will continue to be required to plug this well, or, 2) If the successful bidder does want this well, then we will amend the Lease for this tract to cover this well, in this case the successful bidder will assume full responsibility for such well under this Lease and the bond regarding this well with the Nebraska Oil And Gas Conservation Commission and the Board.

Tract #2 (All of Section 36, T17N R50W, Cheyenne County) is subject to Oil And Gas Lease #8247 previously issued by the Board, the primary term of which will expire on May 10, 2024. Issuance of the new Lease of this tract is contingent upon said Lease #8247 expiring as scheduled in accordance with its terms and provisions on May 10, 2024.

Tract #7 (All of Section 16, T17N R49W, Morrill County) is subject to Oil And Gas Lease #8261 previously issued by the Board, the primary term of which will expire on May 10, 2024. Issuance of the new Lease of this tract is contingent upon said Lease #8261 expiring as scheduled in accordance with its terms and provisions on May 10, 2024.

Such Leases will be for a primary term of five (5) years, will reserve a one-sixth (1/6th) royalty to the Lessor, and will provide for annual delay rentals of \$2.00 per acre and will be sold and issued in all respects under, in accordance with and pursuant to the applicable laws of the State of Nebraska and applicable Rules And Regulations of the Board.
